Hear Together Group Helps Parents of d/HoH Kids

My journey as a parent with a child with hearing loss, is probably not too different from many others. To our surprise my daughter failed the newborn hearing screening after birth. Anxious and unsure what this really meant, we followed up with all the appointments that were recommended. After a very emotional ABR appointment with our audiologist at the time, we finally had a diagnosis. As a new mom and father to this little beautiful ball of light, we could not help but worry about what her future would look like, and what we could do along the way to pave a path of success for her, full of resources and confidence.

It did not take long to get set up with more appointments and be referred to Early Intervention. As many parents may be able to contest, we have had our ups and downs when it comes to providers, therapists, appointments, and the list goes on. But early in our journey we were blessed to be connected with a parent group that has helped us as parents, and my daughter in more ways than I could have ever imagined!

The Hear Together Group was created by Kristin Bergholtz (SLP) and Carly Alicea (Audiologist), to create a platform for parents of children that are Deaf and Hard of Hearing to connect. They have created a safe space where we can come as parents and share concerns, frustrations, successes, and support for each other free of judgement and criticism. Kristin and Carly always provide an opportunity for parents to share, ask questions, or generate a topic if a parent has come with something on their mind. In addition to this open format, they will also have a topic ready or strategies that can be discussed as a group. They have also brought on guest speakers that can provide additional resources and expertise for us as parents. As my daughter is now in first grade, I have found the conversations about transitions into the public school district and advocating for her services on her IEP to be extremely beneficial. I have also benefited from conversations about troubleshooting her hearing aids, or her other assisted technology, such as the DM. I have appreciated sympathy when I lost her hearing aids, and have equally enjoyed being able to share my experiences and successes to help and support other parents. Not only do Kristin and Carly have a wealth of knowledge but the other parents present always provide strategies and suggestions that have worked for their child and can often translate to others. The connections and ideas I have generated from other parents, I truly believe have made a huge successful impact on my daughter's journey.

This group is truly one of a kind, but the success of the group relies on the parent participants. If you have not *(Continued on page 6)*

National Report

The Board of Directors of Hearing Loss Association of America met at headquarters in Rockville, MD Friday November 3 and Saturday November 4. Meetings were chaired by Mike Meyers (Chicago) with all board members in attendance. As per emerging custom, board meetings are hy-



brid (in-person and virtual presence) even while consensus is that face to face discussions are preferable. Over time, the composition of the board has trended to being more nationwide rather than the heavily east coast tilt of some days gone by. Of the 17 elected and ex officio members of the board, four are from the northeast, five are from the greater Washington D.C. area, two are from the southeast, two are from the midwest, and four are from the west coast. The greater geographic dispersion is a welcome advance for the board and the availability of hybrid meetings to allow virtual attendance has been a sometime help for directors who are not east coast.

The agenda included a report from the executive director; committee reports from the finance, development, and nominating committees; a report from the chapter engagement manager; and a donor appreciation letter writing activity to provide board outreach to donors. A Friday evening 'happy hour' and light dinner provided valuable time for directors and staff to be together in a more informal fashion than meeting formats allow.

Report (highlights) from Barbara Kelley, Executive Director:

Barbara made a point of saluting the Rochester and Westchester chapters in the celebrations of their respective fortieth anniversaries this fall.

Barbara reported that the HLAA website re-design is set for an early 2024 debut. The website upgrade will include a new chapter's portal that will aim to organize chapter and state organization support materials in an organized, easy-to-use fashion. More widely, the aim is to have a more welcoming environment for new visitors to the site who are seeking support and information in dealing with their hearing loss or that of a member of their family and who may know little to nothing about HLAA. The aim is to be able to provide useful service to new friends who find us via social media posts and other referrals. Engagement strategies will be employed through social media, blogs, webinars, etc. to attract people to the website.

Recruitment for Lise Hamlin's successor is underway. Lise's retirement is set for mid-winter although she will continue to contribute going forward on a consulting basis with the ICAAT project. Lise is a long-time staffer at HLAA in charge of advocacy efforts...she will be missed.

Membership will be re-defined to include all donors who "opt in" to being considered members. The thinking is that all supporters should receive the benefits of membership if they choose and that widening the scope of who we consider as members will create the potential for a more robust overall dialogue with HLAA's base of support. The details of how this will be implemented is not yet fully worked out. Stay tuned.

HLAA aims, as a strategic proposition, to establish an internal culture of philanthropy that will help the organization sustain itself financially, to better support the grass roots support communities (chapters, state associations et al) and to extend its outreach to underserved populations within the hearing loss community over time. Much of this effort will be about doing a good job communicating what we are doing, how HLAA aims to grow and improve its work, and how important the support of friends and members is to the future sustainability of HLAA. Expectations for Board of Directors involvement in giving and getting funding to support HLAA will continue to have increased emphasis as we see the work being "a team effort" combining the efforts of Board and staff, along with the larger body of HLAA supporters.

One of HLAA's strategic themes is to do a better job of outreach to underserved populations. Barbara highlighted some of our efforts in that regard including convention programming (first Spanish language workshop in New Orleans provided by Roxana Rotundo (Miami) and diversity/equity/inclusion panel comprised of Roxana Rotundo, Ibrahim Dabo (Atlanta) and Carrie Nieman (Johns Hopkins) and the November issue of Hearing Life featuring hearing loss across cultures.

Notice has been received of HLAA's being awarded grant funding to support upcoming research symposia at our national conventions. Funding is through the National Institute on Deafness and Other Communication Disorders of National Institutes of Health (NIDCD/NIH for short) in total funded amount of \$300,000 spread over five years. Thanks to Jan Blustein (New York) for her volunteer services in providing technical support in writing the grant application.

Management is considering plans to add staff to provide information for people with hearing loss regarding the assistive technology landscape. While the need is understood to be significant, the way forward on this front is not clearly developed at this writing. Scope,

scale, specifics not fully understood. More thinking, study, and wider consultation is needed. Funding will be an issue, perhaps. See this space for future developments.

Finance committee chair Michael Stone reported out a preliminary (not yet audited) deficit for the fiscal year ended August 31, 2023 following a half decade of budget surpluses. The fiscal 2023 deficit is not cause for alarm as cost controls remain strong and management continues to develop budgets that reflect strategic plan themes. Recent pressures on revenues (charitable gifts) are consistent with broader trends experienced by many not-for-profit organizations following the economic dislocations occasioned by governmental responses to the Covid pandemic. The financial condition of HLAA remains strong as the board and management over time have developed sufficient financial reserves to buffer difficult short-term macro-economic trends that arise from time to time.

Finance committee also brought forward an updated investment policy for board approval. After discussion, the board voted unanimously to adopt.

Development committee reported that the data cleanup project continued apace. Historically, Walk4Hearing records and other donor records have been maintained in separate software systems, making it difficult to view an integrated picture of HLAA giving over time. In addition, and not unusual for small organizations, the donor database has not been maintained with as much rigor as one would want. Thus, for example, one donor might be identified in multiple ways. (Made -up example: Samuel R. Smith, Sam Smith, and S.R. Smith are one and the same person but identify in the data as three separate persons.) Data clean-ups are extremely detailed and unglamorous projects but can be vital in serving the best interests of the organization and its supporters. The project is nearing its completion in early 2024. Separately, but wholly connected with the data effort, is the implementation of new data software for the Walk4Hearing and of software to make possible the integration of W4H giving results with that of the larger HLAA. The new W4H software made its debut at the recent Houston event and early reports are that the software upgrade has been hailed by W4H participants as a big step forward.

Nominating committee provided a discussion note to full board to foster examination of past practice regarding HLAA board membership as regards employees of the major manufacturers of hearing aids and major cochlear implants. In short, past practice has been to not include employees of these companies on the HLAA board in order to have HLAA board composition be clearly aligned with the HLAA focus on consumer advocacy, representation, and support. The discussion was initiated by nominating committee after an application for board service was submitted by an employee of one of the cochlear implant manufacturers. The committee placed the application on hold pending review of the policy question by full board.

Saturday's discussion was wide-ranging and characterized by a variety of observations and opinions. The application that precipitated the policy review remains on hold. Further review and discussion will follow. Stay tuned.

Melissa Kruse, Chapter Engagement Manager reported on her first months on the job. As a first step, Melissa executed a survey of chapter leaders to get a first impression of the relationship between national and its local communities. She now is fully engaged in dialogue with the HLAA grass roots in the chapters, state associations, and beyond. She appreciates the enthusiastic way in which our local communities are sharing their thinking and experience with HLAA service and the relationship with national HLAA.

Kelly King, Au.D., Ph.D of NIH/NIDCD addressed the board. See this space in the February newsletter for highlights from her talk.

Roc Cinema has a hearing loop and some Saturday matinee movies are open-captioned.

Other Theaters - Regal Theatres, Cinemark Theaters, AMC Theaters, and Movie 10 all indicate on their websites that they have closed captioning devices available by asking at the box office. The Strand Theater in Brockport, has individual displays on goosenecks available .

My Story—Doug Meyer

My name is Doug Meyer. I became a member of HLAA Rochester in 2011 as a consequence of my wife (Nancy) having suffered a severe hearing loss due to Meniere's Disease. HLAA was recommended to us as a source of help by a friend who had taught at NTID. Since that time I have been active in



the chapter as a member of the Scholarship Committee for the past five years and as Assistant Treasurer with Nancy since July 2020. In addition, partially due to my background in math, I served as treasurer of our faculty association at York Central, and currently serve as Finance Chairperson and Special Events Treasurer for our church.


I have been a lifelong resident of Groveland, NY where my parents owned a small farm purchased in 1952. As a young man, my goal was to become a farmer but economic issues directed me to SUNY Geneseo where I received a Masters Degree in Math Education. After a thirty-seven year teaching career in High School Math, I retired to become more active in the family farm which my younger brother and family now operated on a much larger scale. During those thirty-seven years I continued to work on the farm on weekends and school vacations. I feel fortunate to have had an enjoyable and successful career in education, but farming is in my blood. "You can take the boy from the farm, but you cannot take the farm out of the boy".

My hearing loss came about as a result of operating open air tractors (no cabs) on the farm as well as chain saws since we have maintained a wood burning stove for several decades. We still enjoy the cozy warmth of the wood heat ! Having been a member of HLAA for several years before my hearing became problematic, I knew that it was time to consult an audiologist. I am certain that my experience of living through Nancy's hearing loss journey made it easier for me to make the transition to wearing hearing aids. There was little to no hesitation or self consciousness on my part about wearing them. The hearing aids have been very helpful regarding understanding speech. It means so much to be able to carry on meaningful conversations with family members, especially our eleven grandchildren.

HLAA Rochester has been most supportive and encouraging, for both Nancy and myself, in coping with hearing barriers for the past twelve years. Not only have we acquired a great deal of knowledge about living with hearing loss, but we have made many new friends. I truly believe that HLAA has been and continues to be a most important resource for anyone experiencing hearing loss. Life After Deaf (My Misadventures in Hearing Loss and Recovery) A book report by Eric Matson

In my view, this ~ 2018 memoir should be mandatory reading for anyone whose hearing "isn't what it used to

be". The author, Noel Holston, lyricist and journalist, began with gradual loss, but unexpectedly woke one morning profoundly impaired in on ear and totally deaf in the other. He details his challenges with Audiologists, ENTs, Insurance Companies, Surgeons and a failed first cochlear implant, but his most telling revelation for "I can get by..." readers is the



realization of the significant burden his loss was placing on everyone around him... the discovered adverse impact on his wife, client/colleagues, everyday relationships, love life, etc.

His summary admonitions are compelling:

- Protect your (hearing) like the precious gift it is!
- Kick your vanity to the curb, regardless of what type of aid helps!
- Be proactive... admitting your loss is vital to getting others' help!
- Sharpen your other senses... sight, touch, smell, taste!
- Don't risk acting on loss... It will not improve and you "won't get by".
- MAINTAIN A SENSE OF HUMOR... doom & gloom is depressing!


On this last item, Noel provides great personal examples. At the very beginning, he quotes John Donne: "Ask not for whom the bell tolls... it tolls for thee." He then replies: "Bells? What bells?". Later, he observes: "Hearing Loss will make a person renew his or her library card"... "deaf be not proud"... and "I do NOT need CDs for Christmas!".


The authors early experience with Captel's voice-totext telephone was disappointing, but the key word is EARLY. My own 2023 service is fantastic... on both my landline and smartphone!
