#### Leaders Message

I was asked to write this month's Leaders Message, and I want to use it to tell you about a project in Zambia to build a school for audiologists.

Zambia, with a population of around 20.5 million people, has only one audiologist. This highlights a signifi-



cant gap in hearing healthcare services in the country. Dr. John McNamara, AuD., owner of Ontario Hearing Centers, and some of his staff members donated hearing aids to residents through their involvement with Entheos cooperative and Hearing The Call organization. Entheos audiologists

travel to developing countries to fit hearing aids to people who need them.

With only one audiologist in Zambia. Ethnios is a partner with Hearing the Call, Inc. to build a school for audiologists in Zambia. Your Board of Directors is consid-

ering ways in which we can support this effort, and Dr. McNamara will answer questions when he speaks to us in March. Our Board asked for some clarification about the project, and we received a reply from Anna Bogden, a volunteer working on the project. Her comments follow:

## PHASE 1 – PHYSICAL CONSTRUCTION AT THE VILLAGE OF HOPE CAMPUS

The initial phase involves the physical construction of facilities on the Village of Hope campus, with a total cost of \$120,000. Fundraising for this phase began in December 2024, and we expect to be fully funded by the end of 2025. Construction is estimated to be completed within six months after funding is secured, assuming no unforeseen delays in Zambia.

# PHASE 2 – STUDENT AND FACULTY HOUSING FOR TRAINING ACCESSIBILITY

This phase aims to build housing to accommodate both students and professors during extended training periods for certification courses. The estimated cost for this phase is \$130,000. Fundraising will begin once Phase 1 is complete, and we anticipate the construction will take approximately six months following the receipt of funds, pending any delays in Zambia.

#### PHASE 3 – CLINIC AND HOUSING EQUIPMENT

This phase focuses on the acquisition of specialized audiology equipment and classroom/dormitory furnishings for the educational building. The total cost is \$100,000,

and we expect the purchasing process to be completed within three months after funding is received.

#### PHASE 4 – STUDENT SCHOLARSHIPS

The scholarship fund will help support students who wish to attend the training programs but are unable to afford the full certification cost. This fund will be designed by a small committee in 2026. At this time, we have not determined the scholarship amount or the number of scholarships to be awarded per certification program. Our goal is to ensure the sustainability of this scholarship fund for years to come as the program grows. The timeline for this phase is contingent upon the completion of Phases 1-3.

All funds raised through this Capital Campaign go directly to Hearing the Call, a U.S.-based 501(c)(3) organization. These funds are restricted to supporting this project exclusively. If, for any reason, the campaign cannot proceed, unused funds will be held until donors are contacted for further instructions.

Donations made to the campaign will be allocated specifically for the current phase of the project. We are currently fundraising exclusively for Phase 1, the construction of the building, and all contributions will be used for that purpose. A portion of the funds (10%) will be reserved to cover international wire fees, accounting, administration, and travel expenses associated with the campaign. However, no funds will be used for other operational or administrative costs unrelated to the Zambia capital project.

# It's Your Hearing Loss and Only Yours; Moving Beyond Denial

For those people who lose their hearing early in life, or lose a good portion of their hearing suddenly, acknowledging the fact they don't hear normally comes with many feelings, depending on their situation. The people who lose their hearing early have a bit of a head start in the process of dealing with all that comes with living with a hearing loss.

Most people with hearing loss do not lose their hearing in early childhood or due to a sudden event. Most individuals lose their hearing gradually, are mostly unaware of their progressing hearing loss or deny the situation for many years.

The sad reality is for a prolonged period of time most people with hearing loss depend on others to take action to communicate. Others are asked to repeat what they've said, put up with the increased volume on the televisions, act as interpreters, and intervene when the hard of hearing person errs. This situation creates impatience and frustration and often leads to "boisterous" conversations within the family and with well-meaning friends.

What also comes with the denial of hearing loss may be less obvious... the dropping out from social situations to avoid embarrassment, either talking too much to avoid listening in a group situation, or not speaking at all, or "faking" to hide the lack of understanding. The toll paid by the hard of hearing person is often frustration with others, social isolation, and depression.

At some point one is almost forced into reality. Let's look at reality...the television *is* too loud, not *everyone* mumbles, and the sound system wherever you are is not poorly maintained or by bad luck you have the one seat located where the sound system isn't working properly.

Let's face it, you probably have a hearing loss, you are missing out, and you are the one who can take action to make things better. While it's true that at this time there isn't a "fix" to make your hearing normal, you can make the situation better.

Take action! Have your hearing tested, learn what you can do in your particular situation and connect with National HLAA and the HLAA Rochester Chapter, for information, interaction, and becoming a part of a group that really understands.

The annual meeting of HLAA-NYS took place Saturday, December 7 via Zoom connection.



With the close of the calendar year, the normal changes in board of directors membership and officers has taken place. Jon Taylor, Peg Bell, and Jeanine Byrnes are stepping down from board service with the conclusion of their respective three-year

terms. #### Captioned Entertainment Around Rochester

JCC Center Stage - Tickets and information are available at www.jcccenterstage.org or (585) 461-2000. Please specify "Captioned Area". Tickets are \$35-40 with discounts for JCC members, full time students and seasonal subscribers. All captioned performances are on Sundays at 2 pm.

**The Little** - The Little Theatre provides options for people with hearing loss, including hearing amplification headphones in all theaters. The hearing amplification headphones can also be used for descriptive listening.

Theatres 1, 2, 4, and 5, are equipped with Hearing Loop Systems. Personal captioning devices are available for all theaters. Please inquire at the box office.

The Little offers open caption screenings when available. Open captions mean captions are visible to everyone, and cannot be turned off. Open caption screenings are currently shown on Thursdays, along with the first matinees on Sundays (please note some films do not have an open caption version). You can find Open Caption shows via thelittle.org (listed in the showtimes on each film page), and on social media.

The REV (Merry-go-Round) Theatre in Auburn has a state-of-the-art Assistive Listening System, which makes use of FM to transmit sound over radio frequency directly to the listener's ear. While the overall system is

quency directly to the listener's ear. While the overall system is FM, they also have individual induction loops for each device. For information about the REV Theatre's productions, see https://therevtheatre.com/

GEVA Theatre Center - Open Captioning for patrons with hearing loss is provided during the 1<sup>st</sup> Saturday matinee and both performances of the final Wednesday of each Wilson Stage Series production, and the first Saturday matinee of each Fielding Stage Series production.

When booking your seats, mention your interest in open captioning in order to secure the most advantageous view of the display on the right of the stage.

RBTL Live Theater - Open Captioning, made possible by HLAA, is offered during most 1 pm Sunday matinee subscription performances of the Broadway Season, and select other performances. A text display scrolls words in synchronization with the dialogue and lyrics

of the show. Reserve seating in view of the captioning screen in advance or request open captioning for unlisted events, 585.222.5000 or mail@rbtl.org. .

**Roc Cinema** has a hearing loop and some Saturday matinee movies are open-captioned.

**OFC Creations Theatre** at Winton Place has an M system and receivers with hearing loops for T-coils.

**Other Theaters** - Regal Theatres, Cinemark Theaters, AMC Theaters, and Movie 10 all indicate on their websites that they have closed captioning devices available by asking at the box office. The Strand Theater in Brockport, has individual displays on goosenecks available .

- Hearing Loss for Dummies by Frank Lin, MD


- El Deafo by Cece Bell (children/teen graphic novel)

#### **Earbuds are Danger to Hearing**

Earbuds are the "audiologists full employment device". More and more children are being treated for noise induced hearing loss.

Teenagers especially like to listen to their music loud, through earbuds. Earbuds deliver sound directly into the ear canal, which can amplify the volume and lead to potential damage.

Noise Induced Hearing Loss occurs when the hair cells in the inner ear are damaged by loud sounds. These hair cells convert sound waves into electrical signals sent to the brain. Once damaged, these hair cells do not regenerate, leading to permanent hearing loss.

Teenagers are at a higher risk because they often listen to music at high volumes for extended periods, increasing the risk damage to their hearing. According to to the American Academy of Pediatrics, 12.5 percent of kids between the ages of 6 and 19 have hearing loss as a result of listening to loud music, particularly through earbuds at unsafe volumes.

If your children, grandchildren, or an acquaintance is listening to their music through earbuds, and you can hear it, it's too loud. Please try to educate them on the dangers of hearing loss, and that they may be using hearings aids a lot earlier in their lives than they would expect.






